

**JC DogPAC Release of Liability and Indemnification Agreement
"Bone-anza" in City Park**

I acknowledge that I voluntarily have applied to participate and use, with my dog(s), the Iowa City City Park for the "Bone-anza" event.

I understand that the act of being physically present in City Park where many leashed dogs, including my own, will be hunting for dog biscuit treats necessarily involves risks of injury to me, to other people, to my dog(s), and to other dogs. I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon participating in the "Bone-anza" and I choose to voluntarily enter the park and participate, knowing the conditions might become more hazardous and/or dangerous for myself and/or dog(s) and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by participating.

By signing this release of liability and participating in the "Bone-anza" event, I hereby fully and forever release and discharge the City of Iowa City, the Parks and Recreation Department, Johnson County Dog Park Action Committee (JC DogPAC), WOOFABLES, the Gourmet Dog Bakery, and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of City Park. I fully and forever release and discharge the City of Iowa City, the Parks and Recreation Department, WOOFABLES, the Gourmet Dog Bakery, and the Johnson County DogPAC organization and their employees and agents from any and all negligent acts and omissions in the same.

By signing this agreement I also agree to indemnify the City of Iowa City, the Parks and Recreation Department, Johnson County Dog Park Action Committee (JC DogPAC), WOOFABLES, the Gourmet Dog Bakery, and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, brought against any or all of such entities based on my use or intended use of City Park.

I have carefully read this release of liability and understand and fully agree with its contents.
